

## Shop and Win Daily This Eid at Waterfront Market

**Duration:** 18 March till 22 March 2026

### Terms & Conditions

1. Customers who spend AED 200 or more (excluding taxes and fees) per day during the Promotion Period (an “**Eligible Purchase**”) are eligible to receive 1 raffle draw entry for every AED 200 spent on an Eligible Purchase (as defined below).
2. **Prize:** Food shopping vouchers worth AED 1000 each. Total of 10 winners between 18 March to 22 March.
3. “**Promotion Period**” 18 March to 22 March 2026 (both dates inclusive).

7. Multiple purchases from different traders within the Waterfront Market made on the same day may be aggregated to reach a total of AED 200 to be eligible for the Promotion.

  - a. To be eligible to receive a Prize, customers must present original receipts showing a total daily spend of AED 200 or more during the Promotion Period and register by scanning the QR code placed at the registration kiosk

We may also provide your personal data to third-party media organizations and/or government authorities if required.

### **Where do we process your personal data**

Your personal data will be processed in the United Arab Emirates. We will not transfer your personal data outside of the United Arab Emirates.
